5. The “Lake Mountain Sprint” is to be held in Victoria. The first day of the Event is in March, 2010 and the final day of the Event is in March, 2010. (Refer event regulations)
6. The “Suncoast Classic” is not calendared in Queensland in 2010. .

It may also be known as or called the Suncoast Classic Rally, with Silverstone Events Pty Ltd the promoter and operator of the Event.

7. The “Targa West” is to be held in Western Australia. The first day of the Event is in August, 2010 and the final day of the Event is in August, 2010. (Refer event regulations)
8. The “Targa Wrest Point” is to be held in Tasmania. The first day of the Event is 30th January, 2010 and the final day of the Event is 31st January, 2010.
